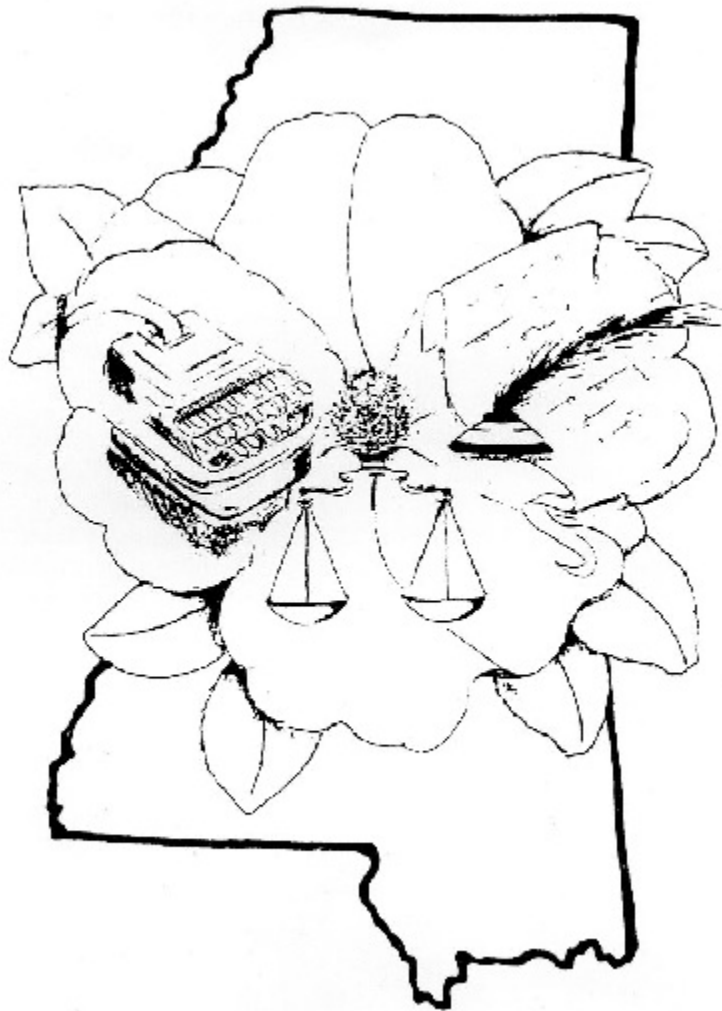

ABOUT THE SEMINAR

The 39th Annual Spring Seminar and Convention for Court Reporters will be conducted by the Mississippi Judicial College at Harrah's Convention Center, 13615 Old Highway 61 North, Robinsonville, Mississippi, 38664 on April 28-30, 2010. The program content was developed by the Continuing Education Committee of the Mississippi Court Reporters working in conjunction with the Judicial College.
